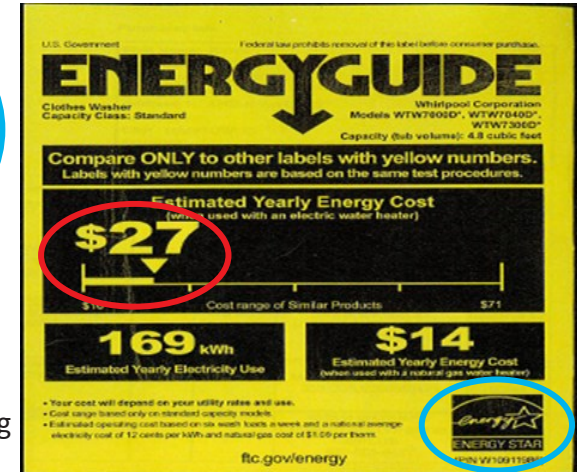

MPU Residential Energy Efficient Appliance Incentive Rebates: January 1 – December 31, 2022

\$50 Rebate for ENERGYSTAR appliances

- Eligible appliances (listed in the table below) which are ENERGYSTAR rated (see the examples circled in BLUE)



Additional \$50 Rebate available for certain appliances

- Eligible ENERGYSTAR rated appliances whose ENERGYGUIDE shows an estimated yearly energy cost in the lower 25% of the range of similar appliances (see example circled in RED)

Details & Conditions

- Available to electric residential customers of MPU who install the appliance at their premise (including renters with electricity included in rent). MPU may inspect the premise to verify the appliance installation.
- Each customer is limited to **TWO** (2) rebates per year (rebates issued by check).
- Submit** with the application the original sales receipt within 60 days of the purchase date on the sales receipt and either:
 - Energy Star Logo (or other verification of ENERGYSTAR rating) OR
 - Energy Guide with EnergyStar logo and showing an Estimated Yearly Energy Cost in bottom quadrant of 'Cost Range of Similar Products'.
- At MPU's sole discretion, the program may be discontinued at any time and for any reason.
- Complete the application below and mail to, or drop off, at Manitowoc Public Utilities, 1303 S. 8th Street, Manitowoc, WI 54220.
